#### **Rules:**

The following are the details and requirements for the nomination;

#### **General Rules for BOD and EC:**

One nomination only for one family for either EC or BOD committees.
 More than a single-family member cannot serve on either the BOD or EC or both during a given term of office.

- 2. You can nominate yourself. You cannot nominate one person for multiple positions.
- 3. The consent of the nominees to serve the nominated positions is required and will be collected during the eligibility/validation process. This is critical to ensure that these nominees adhere the rules & requirements and can perform the necessary duties of the position for the given period.
- 4. In case of any position where multiple members are standing for one BOD position, the current BOD under the leadership of Chair Pradeep Vittalmurthy will take the decision on appointing BOD seat for the duration of the period left by the leaving Board member and no elections will be held
- In case of an election for any <u>EC</u> position (where multiple members are standing/nominated for one position), each 2016 member family (husband and wife aka primary and secondary) gets to cast two votes in the election

- Elections February 25, 2017 and February 26, 2017.
- Election Results Announcement 28th of February 2017.
- Official handover of position will happen in the Sankranti & Ugaadi event which is the first NKK event of the year 2017
